#### Context: Residents

- Long-Term Care Homes have traditionally served residents who have a range of needs for support and health care
- There has been a sharp increase in the proportion of residents with higher needs in recent years & changes in admission criteria have resulted in residents with more complex care needs



#### Context: Residents

- Average length of stay is shorter
- 97% need help with daily activities
- 97% have two or more chronic conditions
- 90% have some form of cognitive impairment
- •38% need monitoring for an acute medical condition

## Context: Caregivers


- 8 million informal caregivers in Canada, representing 25% of all Canadians
- 2 million informal caregivers provide heavy care (20+ hours/week)
- 6 million of these provide care to a senior (75% of all informal caregivers)

# Time Commitment: Response

Family Councils are built to support a diverse range of both formal and informal meetings. Each council can work to agree on schedules and times that work best for them. Meetings are an effective way to collaborate, problem solve and communicate with small and large groups. They allow individuals to come together and establish a collective body.

- 2. Action Oriented Meetings
- 3. Brainstorming or Creative Meetings
- 4. Short Term Planning Meetings





# How To Run a Meeting Effectively


- Avoid the "Complaint Trap"
- Set & stick to an agenda
- Balance support vs. getting work done
- Don't ignore issues
- Focus on your mission/ purpose
- Consider what you want to do outside the meeting



#### Teamwork


In order to work effectively to achieve your goals, your Council needs to come together as a group and work together as a team.

# Misconceptions: Response

The main purpose of a family councils is to improve the quality of life of Long Term Care residents and to give families and friends a forum for sharing their experiences, learning and exchanging information.





#### Back to Basics

- Family Councils contribute to the Home and quality of living for residents in a variety of ways. Council members engage in peer support to support fellow members.
- Councils operate as a communications link between the Home and families, helping to support information flow.





#### Back to Basics

- Councils plan and execute projects hold events with guest speakers to educate residents, families, and staff
- Councils serve an important function in processing concerns that affect all residents and working with the Home to resolve issues and engage in quality improvement

#### Response: Peer Support

 Family Councils not only provide an opportunity to work towards positive change in the Home, but they provide a chance for family members to connect to others who share their experiences and can provide emotional, practical, informational and affirmative support.

At its core, a Family Council is a peer support group



#### Peer Support

The definition of peer support for Family Councils must remain flexible but the following principles apply to both Family Councils and peer support groups:

- Respect
- Confidentiality
- By members for members. For a Family Council, our saying is 'by families for families.'

- Building a culture of positive mutual support
- Advocacy on shared issues
- Education
